(BCCI®) The BCCI Buddhist Task Force developed this document to welcome our Buddhist chaplains and assist in meeting the endorsement requirement. It is our sincere hope that the information requested is described clearly in this document; but if additional information or clarification is needed, contact the BCCI office. Our staff is ready to help and to dialogue with you in this process.

## A few notes:

- BCCI wants to ensure that the chaplain has had the proper training and continued support from the Buddhist community.
- The Sangha/Temple/Dharma Center/Community ("Community") may appoint any one person OR any position to be the official endorser for the group. This information allows BCCI to ensure that a letter of endorsement has come from the authority designated by the group. For example, the official endorser may be a person (John Smith) or may be a position (Dharma Teacher). By asking for an official endorser, BCCI ascertains that the candidate has applied for certification with the proper permission of the group.
